Dear Shareholder

Annual General Meeting of Hummingbird Resources plc (the “Company” or “Hummingbird”)

1. Introduction

I am pleased to be writing to you with details of our Annual General Meeting (“**AGM**”) which we are holding at the offices of Gowlings (UK) LLP on 26 June 2015 at 11:00a.m. The formal notice of Annual General Meeting is set out on pages 6 to 9 of this document.

If you would like to vote on the resolutions but cannot attend the AGM, please fill in the Form of Proxy enclosed with this document and return it as soon as possible to Capita Asset Services at PXS, The Registry, 34 Beckenham Road, Beckenham, Kent BR3 4TU in the prepaid envelope provided. Capita Asset Services must receive the completed Form of Proxy by 11:00a.m. on 24 June 2015.

If you are planning to attend the AGM, I would be grateful if you could confirm this to the Company Secretary by 6.00p.m. on 24 June 2015 either by e-mail (tom@hummingbirdresources.co.uk) or by post to our Registered Office.

2. Business to be transacted at the AGM

Details of the resolutions which are to be proposed at the AGM are set out below.

Ordinary resolution 1: Annual Report 2015

The business of the AGM will begin with a resolution to lay before members the Annual Report in respect of the 7 month period ending 31 December 2014 (the “**Annual Report**”). Shareholders will have the opportunity to put questions on the Annual Report to the directors before the resolution is proposed to the meeting.

Ordinary resolution 2: Appointment of Director

Shareholders are asked to elect as a director Russell King in accordance with Article 25 of the Company’s Articles of Association and who being eligible is offering himself for election.

Ordinary resolution 3: Reappointment of Director

Shareholders are asked to re-elect as a director Matthew Idiens who is retiring in accordance with Article 25 of the Company’s Articles of Association and who being eligible is offering himself for re-election.

Ordinary resolution 4: Reappointment of Director

Shareholders are asked to re-elect as a director Thomas Hill who is retiring in accordance with Article 25 of the Company's Articles of Association and who being eligible is offering himself for re-election.

Ordinary resolutions 5 and 6: Re-appointment of auditors and authority to determine remuneration

Shareholders will be asked to confirm the reappointment of Baker Tilly UK Audit LLP as the Company's auditors to hold office until the conclusion of the next annual general meeting and to grant authority to the directors to determine the auditors' remuneration.

Ordinary resolution 7: Grant of authority to the Directors to allot Ordinary Shares

This resolution deals with the directors' authority to allot Relevant Securities (as defined in the notes to this resolution) in accordance with section 551 of the Companies Act 2006 (the "Act"). This resolution will, if passed, authorise the directors to allot:

- a. in relation to a pre-emptive rights issue only, equity securities (as defined by section 560 of the Act) up to a maximum nominal amount of £631,926.14 which represents approximately two thirds of the Company's issued Ordinary Shares (excluding treasury shares) as at 26 May 2015. This maximum is reduced by the nominal amount of any Relevant Securities allotted under paragraph 7b;
- b. in any other case, Relevant Securities up to a maximum nominal amount of £315,963.07 which represents approximately one third of the Company's issued Ordinary Shares (excluding treasury shares) as at 26 May 2015. This maximum is reduced by the nominal amount of any equity securities allotted under paragraph 7a. in excess of £315,963.07.

Therefore, the maximum nominal amount of Relevant Securities (including equity securities) which may be allotted under this resolution is £631,926.14.

As at close of business on 26 May 2015, the Company did not hold any treasury shares.

This authority replaces a similar authority passed on 15 April 2015 and will expire on the date which is 18 months after the date on which the resolution is passed or, if earlier, the date of the next annual general meeting of the Company.

The directors currently intend only to make use of this authority: (i) in connection with the grant of any options to the directors of the Company and employees of the Company's group; and (ii) as may be necessary to manage the Company's capital resources.

Relevant Securities means:

- *Shares in the Company other than shares allotted pursuant to:*
 - *an employee share scheme (as defined by section 1166 of the Act);*
 - *a right to subscribe for shares in the Company where the grant of the right itself constituted a Relevant Security; or*
 - *a right to convert securities into shares in the Company where the grant of the right itself constituted a Relevant Security.*
- *Any right to subscribe for or to convert any security into shares in the Company other than rights to subscribe for or convert any security into shares allotted pursuant to an employee share scheme (as defined by section 1166 of the Act). References to the allotment of Relevant Securities in the resolution include the grant of such rights.*

Where the aggregate usage by the Company of the authority granted by this resolution exceeds one third of the nominal value of the Company's issued Ordinary Shares (excluding treasury shares) as at 26 May 2015 and also, in the case of issuance being in whole or part by way of a fully pre-emptive rights issue, monetary proceeds exceed one third (or such lesser relevant proportion) of the pre-issue market capitalisation, all directors wishing to remain in office will stand for re-election at the next annual general meeting of the Company following the decision to make the issue in question.

Special resolution 8: Disapplication of statutory pre-emption rights on allotment of shares

If the directors wish to allot unissued shares or other equity securities for cash or sell any shares which the Company may hold in treasury following a purchase of its own shares, the Act requires

that such shares or other equity securities are offered first to existing shareholders in proportion to their existing holdings.

This resolution will, if passed, give the directors power, pursuant to the authority to allot granted by resolution 7, to allot equity securities (as defined by section 560 of the Act) or sell treasury shares for cash without first offering them to existing shareholders in proportion to their existing holdings up to a maximum nominal amount of £189,577.84 which represents approximately 20 per cent. of the Company's issued Ordinary Shares (excluding treasury shares) as at 26 May 2015.

The proposed resolution also disapplies the statutory pre-emption provisions in connection with pre-emptive offers and offers to holders of other equity securities if required by the rights of those securities or as the directors otherwise consider necessary, and allows the directors, in the case of any such offer, to make arrangements in relation to fractional entitlements or other legal or practical problems which might arise.

The total number of Ordinary Shares in issue as at 26 May 2015 is 94,788,922. The Company does not currently hold any treasury shares. This authority replaces a similar authority passed on 15 April 2015 and the power granted by this resolution will expire on the date which is 18 months after the date on which this resolution is passed or, if earlier, the date of the next annual general meeting of the company.

The directors have no immediate plans to make use of this authority other than in those circumstances which are referred to in the explanation relating to resolution 7 above.

Special resolution 9: Purchases of own shares by the Company

Resolution 9 to be proposed at the AGM seeks authority from holders of Ordinary Shares of the Company to make market purchases of Ordinary Shares, such authority being limited to the purchase of 10 per cent. of the Ordinary Shares in issue as at 26 May 2015. The maximum price payable for the purchase by the Company of Ordinary Shares will be limited to an amount equal to 105 per cent. of the average market value of an ordinary share for the five business days prior to the day the purchase is made. The minimum price payable by the Company for the purchase of Ordinary Shares will be 1p per share (being the amount equal to the nominal value of an ordinary share). The authority to purchase Ordinary Shares will only be exercised if the directors consider that it is in the best interests of the Company and the Shareholders as a whole. The Company may either cancel any Ordinary Shares which it purchases under this authority or transfer them into treasury (and subsequently sell or transfer them out of treasury or cancel them). If the Company were to purchase any Ordinary Shares pursuant to this authority it would consider holding them as treasury shares. This would enable the Company to re-issue treasury shares quickly and cost-effectively and would provide the Company with additional flexibility in the management of its capital base.

Options to subscribe for up to 5,660,000 Ordinary Shares and warrants to subscribe for up to 6,563,557 Ordinary Shares have been granted and are outstanding as at 26 May 2015 representing approximately 12.9 per cent. of the issued ordinary share capital of the Company at that date. If the directors were to exercise in full the power for which they are seeking authority under resolution 9, the options and warrants outstanding as at 26 May 2015 would represent approximately 14.3 per cent. of the ordinary share capital of the Company in issue following such exercise.

3. Action to be taken

You are entitled to appoint one or more proxies to attend and vote at the AGM on your behalf. You will find enclosed with this document a Form of Proxy for use in connection with the AGM. Whether or not you propose to attend the AGM in person, you are requested to complete and return the Form of Proxy to Capita Asset Services at PXS, The Registry, 34 Beckenham Road, Beckenham, Kent BR3 4TU in the prepaid envelope provided as soon as possible and, in any event, so as to be received no later than 11:00a.m. on 24 June 2015. Completion and return of a Form of Proxy will not stop you from attending the AGM and voting in person should you so wish.

4. Recommendation

The directors consider that all of the resolutions to be proposed at the AGM are in the best interests of the Company and its shareholders as a whole and unanimously recommend that shareholders vote in favour of all of the resolutions, as the directors intend to do in respect of their own beneficial holdings.

To consider and, if thought fit, to pass the following resolutions, numbers 1 to 7 of which will be proposed as ordinary resolutions and numbers 8 and 9 of which will be proposed as special resolutions:

1. That the Company’s annual accounts for the 7 month period ending 31 December 2014, together with the directors’ report and the auditors’ report on those accounts, be received.
2. That Russell King be appointed as a director in accordance with Article 25 of the Company’s Articles of Association.
3. That Matthew Idiens be reappointed as a director in accordance with Article 25 of the Company’s Articles of Association.
4. That Thomas Hill be reappointed as a director in accordance with Article 25 of the Company’s Articles of Association.
5. That Baker Tilly UK Audit LLP be reappointed as the Company’s auditors to hold office from the conclusion of this meeting until the conclusion of the next meeting at which the accounts are laid before the Company.
6. That the directors be authorised to agree and fix the auditors’ remuneration.
7. That the directors be generally and unconditionally authorised to allot Relevant Securities (as defined in the notes to this Notice):
 - a. comprising equity securities (as defined by section 560 of the Act) of ordinary shares of 1p each in the capital of the Company (“**Ordinary Shares**”) up to an aggregate nominal amount of £631,926.14 (such amount to be reduced by the nominal amount of any Relevant Securities allotted under paragraph 7b. below) in connection with an offer by way of a rights issue:
 - i. to holders of Ordinary Shares in proportion (as nearly as may be practicable) to their respective holdings; and

 - b. in any other case, up to an aggregate nominal amount of £315,963.07 (such amount to be reduced by the nominal amount of any equity securities allotted under paragraph 7a. above in excess of £315,963.07),provided that this authority shall, unless renewed, varied or revoked by the Company, expire on the date which is 18 months after the date on which this resolution is passed or, if earlier, the date of the next annual general meeting of the Company save that the Company may, before such expiry, make offers or agreements which would or might require Relevant Securities to be allotted and the directors may allot Relevant Securities in pursuance of such offer or agreement notwithstanding that the authority conferred by this resolution has expired. This resolution revokes and replaces all unexercised authorities previously granted to the directors to allot Relevant Securities but without prejudice to any allotment of shares or grant of rights already made, offered or agreed to be made pursuant to such authorities.
8. That, subject to the passing of resolution 7, the directors be and are hereby empowered, pursuant to section 570 of the Act, to allot:
 - a. equity securities (as defined by section 560 of the Act) of ordinary shares of 1p each in the capital of the Company (“**Ordinary Shares**”) for cash, either pursuant to the authority conferred by resolution 6 or by way of a sale of treasury shares, as if section

561(1) of the Act did not apply to any such allotment, provided that this power shall be limited to the allotment of equity securities pursuant to an offer or issue by way of rights, open offer or other pre-emptive offer:

- i. to the holders of Ordinary Shares in proportion (as nearly as may be practicable) to their respective holdings; and
- ii. to holders of other equity securities as required by the rights of those securities or as the directors otherwise consider necessary,

but subject to such exclusions or other arrangements as the directors may deem necessary or expedient in relation to treasury shares, fractional entitlements, record dates, legal or practical problems in or under the laws of any territory or the requirements of any regulatory body or stock exchange; and

- b. the allotment (otherwise than pursuant to paragraph 8a. above) of equity securities up to an aggregate nominal amount of £189,577.84.

The power granted by this resolution will expire on the date which is 18 months after the date on which this resolution is passed or, if earlier, the conclusion of the Company's next annual general meeting (unless renewed, varied or revoked by the Company prior to or on such date) save that the Company may, before such expiry make offers or agreements which would or might require equity securities to be allotted after such expiry and the directors may allot equity securities in pursuance of any such offer or agreement notwithstanding that the power conferred by this resolution has expired.

This resolution revokes and replaces all unexercised powers previously granted to the directors to allot equity securities as if section 561(1) of the Act did not apply but without prejudice to any allotment of equity securities already made or agreed to be made pursuant to such authorities.

9. That the Company be and is hereby generally and unconditionally authorised for the purpose of section 701 of the Act to make market purchases (as defined in section 693 of the said Act) of ordinary shares of 1p each in the capital of the Company ("**Ordinary Shares**") provided that:
 - a) the maximum number of Ordinary Shares hereby authorised to be purchased is 9,478,892;
 - b) the minimum price (exclusive of expenses) which may be paid for an ordinary share is 1p per share, being the nominal amount thereof;
 - c) the maximum price (exclusive of expenses) which may be paid for an ordinary share is an amount equal to 105% of the average market value of an Ordinary Share for the five business days prior to the day the purchase is made;
